Consent to Personal Data Processing

If you provide incorrect information or if the Company has reason to believe that the information you have provided is incomplete or inaccurate, the Company has the right, at its discretion, to block or delete your account.

The provision of personal data is a mandatory requirement of the Carriers/Service Providers in such areas as railway and air transport, insurance, etc. The refusal to provide personal data entails the inability to render services as part of the Company's Software Products.

2. For the purposes of this Consent, personal data mean any information relating to a directly or indirectly identified or identifiable individual (personal data subject) that may include, but is not limited to: last name, first name, patronymic, date of birth, gender, ID document details, mobile phone, e-mail, etc.

You are solely responsible for providing false information.

- 3. List of personal data processing activities for which you give this Consent to the Company:
 - Collection obtaining personal data;
 - Systematization;
 - Accumulation;
 - Storage;
 - Clarification (update, change);
 - Use for the purposes of this Consent;
 - Transfer to third parties for the purposes of this Consent, including cross-border transfer;
 - Deletion, depersonalization, blocking and destruction.

- 4. You hereby give your consent to the processing of personal data for the purpose of performing transactions for the sale of Services to the personal data subjects when using the Company's Software Products, including:
 - identification;
 - provision of Software Products to you for further booking of electronic air tickets, aeroexpress tickets, railway tickets, hotels, transfers in Russia and abroad, conclusion of insurance contracts and receipt of other services of the Company;
 - interaction with you, including sending notices, requests and information regarding the use of Software Products and the provision of services by the Company, as well as processing requests and applications. This information includes, but is not limited to, communications for the purposes of confirming bookings, reservations, cancellations, notifications of changes in flight schedules, train movements, aircraft departure/arrival, and other events related to the provision of services by the Company.
- 5. You hereby agree to the following conditions for the processing of personal data and their transfer to third parties:
- 5.1. The confidentiality of the personal data provided to the Company will be ensured, except in cases when you voluntarily provide information about yourself and/or about a third party, acting as its legal representative based on its consent and/or on its behalf, to an unlimited number of persons.
- 5.2. The Company may transfer your personal data to third parties in the following cases:
 - transfer is required as part of the provision of services by the Company and your use of the Company's Software Products;
 - transfer is provided for by the Russian or other applicable laws as part of the statutory procedure;
 - transfer takes place as part of the sale or other transfer of the business (in whole or in part), and the transferee assumes all obligations to comply with the terms of this Consent with respect to the personal data it receives;
 - in other cases provided for by applicable Russian and/or other laws.
- 6. The Company will take the necessary and sufficient technical and organizational measures to protect your personal data from an unauthorized or accidental access, destruction, modification, blocking, copying, distribution, and other illegal actions of third parties.
- 7. By ticking the field "I give my consent to the processing of personal data" in the Software Products, you accept the terms of this Consent, namely, you give your consent to the provision and processing of personal data by the Company. You accept the terms of this Consent fully and unconditionally, without any exceptions and/or limitations. The term of this Consent is not limited.
- 8. This Consent is valid indefinitely and may be withdrawn by you by clicking the "Delete Personal Data" button in the Software Products, as part of a complete refusal to process personal data, or by sending a written or electronic request (Withdrawal of Consent to Personal Data Processing) to the Company. If you have not withdrawn your consent, your personal data will be destroyed or depersonalized after achieving the purposes of processing by the Company.
- 9. By providing personal data of third parties to the Company, you guarantee the legality and legitimacy of their receipt, the availability of the personal data subjects' consent to the data provision to the Company, as well as the validity of the said data.

- 10. You may submit any notices, requests, claims, applications, complaints and other inquiries to the Company, whether provided for or not in this Consent, by any means whatsoever.
